## Pension Fund Changes?? Retirement Plans?? What??? When???

As members are aware there is a study regarding the Pension Fund due by the Walker Administration on June 30, 2012. Members are encouraged to visit the website about any changes to our benefits.

There is talk of changing the system and/or change so it is not in a public system. One proposal is for state employees to work with private investment firms individually and to allow new employees to elect not to join the retirement system. Studies done previously have shown the public pension systems can do the job cheaper than any other type of system. Of course, those who don't want any public sector employees to have any benefits won't let the facts get in their way. There is nothing yet to finalize any changes.

ETF feels the benefits you accrued are yours and there is no legal precedent for altering the amounts you have in your accounts retroactively. Yes, they could change things from now until the future, but can't take benefits in your account retroactively.

It is felt there would be some advance warning of an impending change to let employees file retirement papers. Some changes require changes to statutes, some require changes to rules and others could be changed if the Governor gets up in the morning and decides he wants to do something. However, to have those changes go into effect, other people typically have to do something to make those changes happen. It is felt people will be made aware of this in time to do something about it.

### Knowing this, how should you prepare yourself for the future??? THIS IS THE IMPORTANT PART!!!!

Anyone 55 or over should have retirement estimates done, beneficiary designation paperwork done, and retirement payment options figured out to be able to act quickly. In your desk, keep a copy of a letter that states you are retiring and your last day of work, leave the signature and the date blank and have that "at the ready". There is no requirement for a 2 week notice - you can retire the same day you turn in the letter. See your HR dept. to get an example letter, if they have one or they could give you the basic requirements. The DNR has a check list for retiring on the DNR HR Intranet site.

Everyone in a position to retire should consider being prepared and ready to retire within a day or two if needed. In Madison, people talk about giving retirement notice to the employer and driving to the ETF offices on Park Street/Badger Rd. and turning it in 'in person'. Giving the retirement application to your employer or mailing it may add to unnecessary delay in your effective date.

In summary, nothing has changed yet. It could change. If you are interested in tracking what is happening with our retirement benefits, etc., you can go to <u>etf.wi.gov</u> and look for a **red envelope** at the bottom of the home page. There you will be able to sign up for alerts from ETF.

### AFT SCHOLARSHIP NEWS: APPLICATION PERIOD FOR <u>2011-2012</u> SCHOLARSHIPS IS <u>NOW OPEN.</u>

### Applications are due to AFT-Wisconsin by March 15.

### WINNERS WILL BE NOTIFIED BY MAY 1.

The application is available at <u>www.aft-wisconsin.org</u>.

AFT-Wisconsin has a long tradition of offering educational scholarships to support dependents of members in good standing who wish to pursue a career in labor, education, health care or government service. Currently, AFT-Wisconsin offers three \$1,000 university scholarships and two \$500 technical school scholarships.

#### **Eligibility for Scholarships:**

Applicant's parent, grandparent or guardian must be a current AFT-Wisconsin member or a retiree in good standing of AFT-Wisconsin for more than one year. The individual must be accepted into an accredited college, university or technical college at the time the award is issued. Preference for the <u>2011-2012</u> scholarships will be given to applicants with an expected high school graduation date of June <u>2012</u>. However, if scholarships are still available after these have been evaluated or if no current graduates apply, past graduates will be considered. Graduate students are not eligible.

#### **Evaluation criteria:**

Applicants for scholarships are evaluated according to graduation date, academic rank, extracurricular and school activities, leadership skills, family union activity, essay and recommendations.

#### Funding:

The Memorial Scholarships are funded by both contributions from AFT-Wisconsin and voluntary contributions.

#### **Timelines:**

Applications are due to AFT-Wisconsin by March 15. Recipients will be notified by May 1. Letters of Recommendation addressed to entities other than AFT-Wisconsin will not be considered.

#### Letters of Recommendation addressed to entities other than AFT-W will not be considered.
